Her unusual background as an executive in social services as well as a former police sergeant give her insight into complex challenges facing the U.S. justice system. She is widely consulted on trauma-informed public policy questions. Since 2013, she has educated over 12,000 people on civil and criminal aspects of sexual exploitation, including international audiences through the UN Office on Drugs and Crime, and has assisted approximately 2,000 survivors of human trafficking with employment, court assistance, housing, and even helped deliver a baby.
